PURCHASE CONTRACT

This Contract is made and entered into by and between St. John's Northwestern Military Columbarium, Inc., a Wisconsin nonstick corporation (the "Seller"), owner and operator of St. John's Northwestern Columbarium (the "Columbarium"), located in the City of Delafield and the County of Waukesha, State of Wisconsin, and:

hereinafter called the "Purchaser". Witnesseth that, for and in consideration of mutual covenants herein contained, the Purchaser agrees to buy, and the Seller agrees to sell, the interment/scattering rights described in this Contract on the terms and conditions set forth herein.

**1. DESCRIPTION OF RIGHTS** (check and complete either A or B):

B. The right to use the designated scattering grounds of the Columbarium for the scattering of cremated human remains.

The ownership and subsequent use of the right of interment/scattering in the Columbarium herein purchased shall, at all times, be subject to the limitations, restrictions and conditions of all rules and regulations of the Seller now in force or hereafter enacted, which rules and regulations, as constructed by Seller, are made a part of this Contract as though herein set forth and as such shall be kept observed.

E. The interest purchased by the Purchaser under this Contract is a limited and restricted right to use the columbarium niche described herein or scattering grounds for the interment/scattering of the cremated remains of not more than one human being. Included in the purchase price is an interment service in the Columbarium adjacent to the St. John's Northwestern Victory Memorial Chapel and a name plate to be installed by Seller identifying the name of the deceased and the years of the deceased's birth and death. Purchaser is responsible for arranging for all cremation services at Purchaser's expense.

**2. CASH SALE:** The total price for The Columbarium full plate described is \$995.00, payable in cash upon execution of this Contract. Half plates cost \$595.
